7. NEW BUSINESS:

A. Introduction - Ordinance No. 05-2023: The Mayor to read the said Ordinance by Title:

CALENDAR YEAR 2023 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (*N.J.S.A.* 40A:4-45.14) IN THE BOROUGH OF SEA GIRT, MONMOUTH COUNTY, NEW JERSEY

WHEREAS, the Local Government Cap Law, *N.J.S.A.* 40A:4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A:4:45-15a provides that a municipality may, when authorized by ordinance, appropriation the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Borough Council of the Borough of Sea Girt in the County of Monmouth finds it advisable and necessary to increase its CY2023 budget by up to 3.5% over the previous year's final appropriations in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Borough Council hereby determines that a 1.0% increase in the budget for said year, amounting to \$56,961.10 in excess of the increase in final appropriations otherwise permitted by the local Government Cap Law is advisable and necessary; and,

WHEREAS, the Borough Council hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of Sea Girt, in the County of Monmouth, a majority of the full authorized membership of this governing body affirmatively concurring, that in the CY2023 budget year, the final appropriations of the Borough of Sea Girt shall, in accordance with this Ordinance and *N.J.S.A.* 40A:4-45.14, be increased by 3.5%, amounting to \$199,363.85 and that the CY2023 municipal budget for Borough of Sea Girt be approved and adopted in accordance with this Ordinance.

BE IT FURTHER ORDAINED that any amount authorized hereinabove that is not appropriated as part of the final year budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

BE IT FURTHER ORDAINED that a certified copy of this Ordinance as introduced be filed with the Director of the Division of Local Government Services within five (5) days of introduction.

BE IT FURTHER ORDAINED that a certified copy of the Ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within five (5) days after such adopted.

• R-69-2023: Self-Examination of Budget

UPON MOTION of Councilman Downey, seconded by Councilwoman Richman, carried, that the following Resolution be and the same is hereby adopted:

WHEREAS, *N.J.S.A.* 40A:4-78b has authorized the Local Finance Board to adopt rules that permit municipalities in sound fiscal condition to assume the responsibility, normally granted to the Director of the Division of Local Government Services, of conducting the annual budget examination; and

WHEREAS, N.J.A.C. 5:30-7 was adopted by the Local Finance Board on February 11, 1997; and

WHEREAS, pursuant to *N.J.A.C.* 5:30-7.2 through 7.5, the Borough of Sea Girt has been declared eligible to participate in the program by the Division of Local government Services, and the Chief Financial Officer has determined that the local government meets the necessary conditions to participate in the program for the 2022 budget year.

NOW, THEREFORE, BE IT RESOLVED by the governing body of the Borough of Sea Girt that in accordance with *N.J.A.C.* 5:30-7.6a & 7.6b and based upon the Chief Financial Officer's certification, the governing body has found the budget has met the following requirements:

- 1. That with reference to the following items, the amounts have been calculated pursuant to law and appropriated as such in the budget:
 - a. Payment of interest and debt redemption charges
 - b. Deferred charges and statutory expenditures
 - c. Cash deficit of preceding year
 - d. Reserve for uncollected taxes
 - e. Other reserves and non-disbursement items
 - f. Any inclusions of amounts required for school purposes.
- 2. That the provisions relating to limitation on increases of appropriations pursuant to *N.J.S.A.* 40A:4-45.2 and appropriations for exceptions to limits on appropriations found at *N.J.S.A.* 40A:4-45.3 et seq., are fully met (complies with CAP law).
- 3. That the budget is in such form, arrangement, and content as required by the Local Budget Law and *N.J.A.C.* 5:30-4 and 5:30-5.
 - 4. That pursuant to the Local Budget Law:
 - a. All estimates of revenue are reasonable, accurate and correctly stated,
 - b. Items of appropriation are properly set forth
 - c. In itemization, form, arrangement and content, the budget will permit the exercise of the comptroller function within the municipality.
- 5. The budget and associated amendments have been introduced and publicly advertised in accordance with the relevant provisions of the Local Budget Law, except that failure to meet the deadlines of *N.J.S.A.* 40A:4-5 shall not prevent such certification.
 - 6. That all other applicable statutory requirements have been fulfilled.

R-2023: Authorize the Hiring of a Telecommunications Consultant for The Borough of Sea Girt 5G Siting and Capability Management through The Competitive Contracting Process. Councilman Zakin requested to carry this resolution to the June 14th meeting for further review.

8. COUNCIL REPORTS: Councilpersons Downey, Zakin, Richman and Council President Anthony had no report.

Councilman Clemmensen reported The Light House is open for the season on Sundays between 2-4 pm; The Annual Meeting kicks off on May 16th at 7:30 pm; The Annual Light House Party is Saturday, August 5th between 6-8 pm; Annual Membership is from May 1st through April 30th. He encourages the public to drive defensively; secure your homes and remember to remove key fobs. He thanked DPW for their efforts with bulk pickup; spring leaf pickup is over for the season; May 31st weekly recycling resumes.

Mayor Fetzer reported the Fire Department will have their annual smoke house drill at The Monmouth County Fire Academy; they will also have a walkthrough and a practice drill at The Parker House once renovations are complete. The library met last week and reported on May 13th from 10:30-11:30 am, Vinnie Dicks will speak at the library on his Sea Girt and surrounding towns books including the Forsaken Kings: Emma Spreckels The Surfer of Asbury Park. Mayor Fetzer also reported he received a Fireman Application from Alex Branch; he will be attending the Monmouth County Fire Academy for his certification.

9. ADMINISTRATIVE REPORT

Mr. Gant reported The Monmouth County Shade Tree Commission has been throughout Sea Girt trimming, removing and planting trees; the shared service agreement has been working well and he will continue to negotiate costs as the relationship continues. He further noted Bird Watching for beginners guided by Ray Bogan begins 10:00 am at Edgemere Park on May 20th (raindate May 21st). He further commented that on Monday, May

29th at 8:45 is the kickoff for the Memorial Day Parade starting at Bell Place. A pre-construction meeting was held today with Fernandes Construction on the Fifth Avenue paving project, which could start on May 19th on inlets and curbing only.

Justin Mako reported on Police Department activity; Randy Maccanico is completing the EMT Program, once he passes the test, he will be the first EMT in the Police Department. He thanked Robert DeMartin for his presentation and all his efforts with the program. He reminded the public that low speeding vehicles have to be insured and operated the same as any motor vehicle in New Jersey. A department head meeting is scheduled before Memorial Day weekend to cover summer protocol. He asked to keep Officer Shisler in your thoughts and prayers. MS Mike Tour is May 20th throughout the day.
