g. Resolution No. 84-2021: Governing Body Certification of Compliance with the United States Equal Employment Opportunity Commission's "Enforcement Guidance on The Consideration of Arrest and Conviction Records in Employment Decisions Under Title VII of The Civil Rights Act of 1964";

WHEREAS, <u>N.J.S.A.</u> 40A:4-5 as amended by P.L. 2017, c.183 requires the governing body of each municipality and county to certify that their local unit's hiring practices comply with the United States Equal Employment Opportunity Commission's "Enforcement Guidance on the Consideration of Arrest and Conviction Records in Employment Decisions Under Title VII of the Civil Rights Act of 1964," *as amended*, 42 U.S.C. § 2000e *et seq.*, (April 25, 2012) before submitting its approved annual budget to the Division of Local Government Services in the New Jersey Department of Community Affairs; and

WHEREAS, the members of the governing body have familiarized themselves with the contents of the above-referenced enforcement guidance and with their local unit's hiring practices as they pertain to the consideration of an individual's criminal history, as evidenced by the group affidavit form of the governing body attached hereto.

NOW, THEREFORE BE IT RESOLVED, That the Borough Council of the Borough of Sea Girt, hereby states that it has complied with <u>N.J.S.A.</u> 40A:4-5, as amended by P.L. 2017, c.183, by certifying that the local unit's hiring practices comply with the above-referenced enforcement guidance and hereby directs the Clerk to cause to be maintained and available for inspection a certified copy of this resolution and the required affidavit to show evidence of said compliance.

h. **Resolution No. 85-2021:** Authorizing an Interlocal Services Agreement Among The Borough of Brielle, Borough of Manasquan and Borough of Sea Girt for the Provision of Road Salt

WHEREAS, the Borough of Brielle and the Boroughs of Sea Girt and Manasquan are municipal corporations in the County of Monmouth, State of New Jersey and have been formed in compliance with applicable statues; and,

WHEREAS, the Borough of Brielle and the Boroughs of Sea Girt and Manasquan previously entered into an agreement under the provisions of N.J.S.A. 40:8A-1 the "Interlocal Services Act" in order to provide for the construction of a structure (the "salt dome") for road salt storage; and,

WHEREAS, the salt dome has been constructed and is fully operational for the storage of road salt that is currently utilized by all three participants; and,

WHEREAS, all initial construction costs have been met and there is little or no annual maintenance of the salt dome required.

NOW, THEREFORE, BE IT RESOLVED that the Agreement for the provision of road salt is hereby approved for the period commencing retroactively to May 1, 2021 through December 31, 2026, inclusive, and the Mayor and Municipal Clerk are hereby authorized to execute the said Agreement.

i. **Resolution No. 87-2021:** Authorize Master Services Agreement with Rave Wireless, Inc. and SwiftReach Networks, LLC and The Borough of Sea Girt

WHEREAS, in accordance with N.J.S.A 40a:11-15 The Borough Qualified Purchasing Agent and Clerk has reviewed the Master Service Agreement submitted by Rave Wireless, Inc. and Swiftreach

Network, LLC and determined that the proposal meets the needs of the Borough and that the value of the services to be provided will be \$21,000.00 for the period effective May 1, 2021 through April 30, 2024 for Rave Alert for Public Safety Services; and

WHEREAS, The Borough of Sea girt would like to authorize the agreement for thirty six (36) months with Rave Wireless, Inc. and Swiftreach Network, LLC, 492 Old Connecticut Path, Framingham, MA 01701 in the amount of \$7,000 per year for a term of 36 months for Rave Alert for Public Safety Services; and

WHEREAS, The Chief Financial Officer has certified that funds are available for this purpose; and

NOW THERFORE BE IT RESOLVED, that the Borough Council of the Borough of Sea Girt authorizes the Mayor and Municipal Clerk to enter into an agreement for the purpose as described herein.

b. Resolution No. __2021: Approve Improvements to Crescent Park for a Racquet Sports Recreation Area to Include a Second Platform Tennis Court and Viewing Area in The Borough of Sea Girt - *tabled*.

Councilwoman Anthony commented she is concerned about the length of the process with regard to amending the Forest Stewardship Plan as the hold up for the paddle court; thus extending the open councilmember discussion with Mr. Bogan, and not tabling, but carrying, in anticipation of hearing from the State. She also noted there was a notation in the Forest Stewardship Plan (page 16) that due to the amount of Holly trees dominating the forest, where other tree and plan species are not able to thrive, thus inhibiting a healthier overall ecosystem within the park, some thinning of Holly trees was recommended.

Councilwoman Giegerich noted there that there seems to be a disconnect among the community, noting The Stewardship Plan was donated by a private resident.

Section 2. Section 10.3.2 is hereby supplemented as follows:

10-3.2.1 Upon conviction for a violation of Chapter X, subsection 3.1.1, a fine of not less than two hundred fifty (\$250.00) dollars nor more than one thousand (\$1,000.00) dollars shall be imposed

Section 3. All Ordinances or parts of Ordinances inconsistent herewith are hereby repealed, but only to the extent of such inconsistency.

Section 4. If any section or provision is stricken, or deemed to be contrary to the law or constitution then that section, alone, will be stricken and the balance of this ordinance shall remain in full force and effect.

Section 5. This Ordinance shall take effect twenty (20) days after adoption and final publication as required by law.

9.1(aa). No person shall smoke a cigar, cigarette, pipe, cannabis, cannabis related product or synthetic cannabis, or otherwise use tobacco products on the beachfront, boardwalk, beach, or boardwalk access pathway at any time.

Section 2. Section 9-1.5 f. Upon conviction for a violation of subsection 9-1.aa, a fine of not less than two hundred fifty (\$250.00) dollars nor more than one thousand (\$1,000.00) dollars shall be imposed.

Section 3. Chapter 3, Section 3-13.2 Definitions, Litter is hereby expanded to include any debris or residue from a cigar, cigarette, pipe or other tobacco products.

Section 4. All Ordinances or parts of Ordinances inconsistent herewith are hereby repealed, but only to the extent of such inconsistency.

Section 5. If any section or provision is stricken, or deemed to be contrary to the law or constitution then that section, alone, will be stricken and the balance of this ordinance shall remain in full force and effect.

Section 6. This Ordinance shall take effect twenty (20) days after adoption and final publication as required by law.

8. **ADMINISTRATOR REPORT**

Mr. Gant commented he is still seeking feedback from our Engineer, Peter Avakian regarding the water table issue at 219 Neptune Place and he will provide update when available; April's newsletter provides updates on multiple Ordinances.

9. **COUNCIL REPORTS** – Mayor Farrell had no report.

Councilman Clemmensen commented as follows:

- Thanked Mr. Gant for his informative newsletter;
- 163 active cases; 3 active cases currently;
- Covid Vaccines available at the Sea Girt Fire Company on May 1st;
- No parking on Seaside and Neptune Place is pending Ordinance updates; Police Department is prepared to install temporary No Parking until Ordinance is adopted;
- Chief Macko anticipates introducing Ordinance at May 12th meeting;

Councilwoman Anthony reported as follows:

- Building & Grounds: trees have been removed along the Bike Path and other areas marked by Mr. Brash;
- Monument Committee Ceremony will be at the Plaza on June 12th;
- Thanked the Sea Girt Conservancy for their continued efforts on our parks;
- Thanked Councilmembers for passing the PASI allowing the Conservancy to move forward with their plans.

Councilwoman Giegerich reported as follows:

- Linda McGeehan will retire May 1st after 32 years of service to the Borough;
- Beach WrstBnd Inc., will train our beach personnel in time for Memorial Day Weekend;
- Library received a cost estimate from Cornerstone Architects for improvements to Library; it is being revised on based on their immediate needs.

Council President Fetzer reported with the vacancy of Councilman Mastrorilli, he will discuss with Councilmembers on recommendations on committee reassignments prior to next meeting.

10. PUBLIC PARTICIPATION ON ANY SUBJECT: (Comments limited to 7 minutes)

Stephen Doyle, Architect with Clark, Caton Hintz presented a slide show for the proposed Bell Place location.

Alan Zakin, 316 Baltimore Boulevard thanked Councilmembers for their support to improve parks; he also thanked Councilman Mastrorilli for his service. He encourages councilmembers to explore the entire Stewardship Plan and properly review prior to submitting to the State.

Borough Attorney, Ray Bogan clarified when the Borough received the Stewardship Plan, it wasn't signed by the Mayor, nor was there a breakdown of prior meeting minutes; the plan was submitted to the State, which was approved, thereafter signed by the Mayor on behalf of the Borough.

Phillip Vasan, 619 Ocean Avenue, thanked council to hear the alternatives of an additional paddleball facility at Bell Place; he supports the Bell Place location.

Catherine Metcalf, 103 Ocean Avenue, questioned if the penalty for leaving the Library is a one year penalty? Mr. Gant responded it is a statutory equation given by the State; the Library does not anticipate spending money, therefore will return to the budget next year. She then asked for an update on the First Avenue Loading Zone. Mr. Bogan responded he continues to negotiate to work with the County and The Parker House to provide a resolution and a plan for First Avenue loading zone. Chief Macko commented Taxis and Ubers will take place on Beacon Boulevard. Mrs. Metcalf thanked Councilman Mastrorilli for his service.

Eileen Laszlo, 204 Philadelphia Boulevard, commented we are all stewards of our greenspace; spectacular wildlife in our area; encourages more biking.

Chief Macko thanked Mayor and Councilmembers for promotion of Jeremy Sorentino and Matthew Mason.

Sharon Kregg, 613 Brooklyn Boulevard, supports additional paddle court at Bell Place.

There being no further comments, the public comment period was closed. There being no further business, and **UPON MOTION** of Council President Fetzer, seconded by Councilwoman Anthony, carried, that the meeting be immediately and finally adjourned at 8:45 PM.
