**OPEN DISCUSSION:** Mayor Fetzer asked Borough Attorney Ray Bogan to comment on the recent petition being circulated regarding Improvements to Crescent Park. Mr. Bogan commented that Sea Girt is a Borough Form of Government; the petition recently circulated falls under the Faulkner Act which is not the act which dictates the Borough Form of Government; the Iniative and Referendum provisions do not apply to the Borough Form of Government; the petition can be brought in for purposes of advisement and consideration of councilmembers; it is not a binding document that will be put on the ballot in November.

Administrator Gant noted the resolution awarding CME Associates is for engineering services to complete a Facilities Condition Assessment Report in the Borough Hall, Police and Fire Departments.

# **UNFINISHED BUSINESS:**

1. **Ordinance No. 16-2021**: The Mayor to read the said Ordinance by Title, advising of its publication in its entirety in the Coast Star on August 19, 2021:

AN ORDINANCE TO AMEND CHAPTER 4, LICENSING AND BUSINESS REGULATIONS PARAGRAPH 4-2.5 "NO SOLICITING" SIGNS; VIOLATIONS IN THE BOROUGH CODE IN THE BOROUGH OF SEA GIRT

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE BOROUGH OF SEA GIRT, as follows:

**Section 1**. All Residents of the Borough of Sea Girt may register their address with the Municipal Clerk to be placed on the Do-Not-Knock-Registry, indicating that they do not want peddling, itinerant vending and door-to-door sales enterprises to approach their homes on their premise. Registration shall be by completion of a form made available by the Borough Clerks office.

**Section 2**. Residents shall remain on the Do-Not-Knock Registry until such time as they advise the Borough Clerk in writing that they wish to be removed from the list.

**Section 3.** The Municipal Clerk shall maintain the list, keep it current, and provide copies to the Police Department who shall be charged with enforcement and shall provide each solicitor, canvasser, hawker or groups thereof, with a copy of the list to ensure their compliance (Ord. #02-2011).

**Section 4**. It shall be unlawful for any person or entity required to obtain a permit pursuant to Chapter 4 to enter the approach and/or seek contact from a residence registered on the Do-Not-Knock-Registry.

**Section 5.** Any persons subject to this chapter who violates any provision of this section shall be subject to a maximum ordinance violation per offense as provided in Paragraph 4-2.9.

**Section 6.** All Ordinances or parts of Ordinances inconsistent herewith are hereby repealed, but only to the extent of such inconsistency.

**Section 7.** This Ordinance shall take effect twenty (20) days after adoption and final publication as required by law.

**UPON MOTION** of Council President Anthony, seconded by Councilman Clemmensen, carried, that the meeting be opened to the public for comments on the said Ordinance only. There were no comments from the public participating and **UPON MOTION** of Councilman Clemmensen, seconded by Councilman Begley, carried, the public hearing was closed.

Ordinance No. 17-2021: The Mayor to read the said Ordinance by Title:

**BE IT ORDAINED,** by the Governing Body of the Borough of Sea Girt that Chapter 12, Section 12-1.6 entitled "Construction Fees" is hereby repealed to be replaced by a new section to read as follows:

#### Section 12-1.6 Fees:

The Borough of Sea Girt is a participant in a Regional Construction Office. Therefore, in compliance with the regulations promulgated by the State of New Jersey Department of Community Affairs, all fees shall be in accordance with the master fee schedule as established by the community hosting the regional Construction Office. Currently that community is the Borough of Spring Lake.

All current and future fee schedules shall be in compliance with the master fee schedule for the duration of the Borough of Sea Girt's membership in the Regional Construction Office.

**BE IT FURTHER ORDAINED**, that all ordinances or parts of ordinance inconsistent with the foregoing are hereby repealed, but only to the extent of the inconsistency.

**BE IT FURTHER ORDAINED,** that this ordinance shall take effect immediately upon passage and publication according to law.

**UPON MOTION** of Councilman Clemmensen, seconded by Council President Anthony, carried, that the said Ordinance be and the same is hereby adopted on first reading, directing the Clerk to post and publish as required by law and setting the date of the public hearing as October 13, 2021.

**WHEREAS**, The Borough of Sea Girt is in need of a 33 Cubic yard Loadmaster Rear Load Packer to replace the existing number four 1998 Volvo garbage truck; and

WHEREAS, Allegiance Trucks is an authorized vendor under Sourcewell CO-OP #060920-NVS; and

**WHEREAS**, the Supervisor of Public Works recommends award of a contract to Navistar (through Allegiance Trucking) in the amount of \$224,785.08; and

**WHEREAS**, The Chief Financial Officer has certified funds in the amount of \$224,785.08 for the Rear Load Packer; and

**NOW, THEREFORE, BE IT RESOLVED**, by The Borough Council of the Borough of Sea Girt, hereby authorizes the purchase of one (1) Packer - Rear Loader from Navistar (through Allegiance Trucks) under Sourcewell CO-OP #060920-NVS for a total expenditure of \$224,785.08 is hereby approved, subject to the issuance of the appropriate purchase orders to Allegiance Trucks, Robert Feldman, 525 West Linden Ave., Linden NJ 07036.

# **COUNCIL REPORTS:**

Councilman Clemmensen asked residents to refer to their DPW Sanitation and Recycling Calendar for important trash, recycling and brush pickup dates. Children are back to school, please drive with caution and cross where crossing guards are present. He reminded parents that helmets are required for children under 17 years of age. He also reminded residents to remove key fobs and valuables from their cars. He also asked residents to review hurricane season checklist and have a plan if evacuated. There are seven streetlights out and they have been reported to JCP&L.

Councilman Perry reported there was a deposit made from the Sea Girt 5K in the amount of \$41,720 to the recreation trust; he thanked Mr. D'Altrui and his committee for all their efforts; a contribution was made to the Reeve Foundation for \$17,500.00. He noted there is a concert Saturday night at the Plaza beginning at 6:30 pm; September 18th is a Farmer's Market in the green space area near the Library from 10 am -2 pm; there is also the Luau from 6-8 pm at the Beach on Beacon Boulevard.

Councilman Begley reported the Finance Committee will meet to summarize the beach season financials.

Council President Anthony commented she is anticipating a report on mechanical, electrical and plumbing assessments with recommendations for improvements at the Borough Hall. She attended an Environmental meeting recently and discussed the box culverts from Wreck Pond to the ocean; they also discussed a program a recycling program "leave only your footprints." There will be herbicide applications in the areas of Crescent Park, Edgemere Park and The Terrace regarding the non-native evasives recently mowed to improve our parks the week of September 20<sup>th</sup>. She asked residents to be

cognitive of the devastating spotted lantern fly, there is information on our website and on the Sea Girt Conversancy website.

Councilwoman Giegerich read Jim Freda's beach summary; she thanked Jim Freda for his efforts during the summer season; he is recommending for next summer that Wi-Fi be available for the entire boardwalk, using wristband exclusively, eliminate community pass, family bathroom renovation, and five new bike racks. He also recommended additional mobi mats for easier wheel chair access; the Borough is applying for a grant through the Reeve Foundation. She then read a beach summary from Tim Harmon; weather permitting lifeguards will be on duty weekends only through the end of September. She thanked Tim Harmon and the lifeguards for assisting in Cape May incident and all their efforts during the summer.

Mayor Fetzer commented as a Library Trustee, he attended a meeting on The Monmouth County Library; he also commented as a member of the Planning Board that they do a great job.

# **ADMINISTRATOR REPORT:**

Mr. Gant welcomed everyone to the 911 20<sup>th</sup> Remembrance Ceremony on Saturday at 8:30 am at the Plaza; that evening is also a Light Up The Shore event at 8:46 PM at Beacon Boulevard Beach. He noted council is trying to return to in-person/hybrid council meetings in October at the school. Westside Bike Path project should start by end of September. The Noise Ordinance is still being reviewed to address noise concerns in the Borough.
