#### 2. NEW BUSINESS

- A. Resolution No. 31-2019: Resolution to Approve the issuance of the Retail Plenary Consumption License #1344-33-003- for CG Jersey, Inc. t/a Fratello's pursuant to *N.J.S.A.* 33-1-12.18, for the period July 1, 2018 through June 30, 2019, inclusive.
  - Acting Director's ruling pursuant to *N.J.S.A.* 33:1-12.18;
  - Correspondence from DAG Lisa Barata clarifying that a full background check is not required;
  - 12-page application;
  - Affidavit of Publication certifying compliance with advertisement requirements of *N.J.A.C.*, 13:2-2.5
  - Tax Clearance Certificate issued June 15, 2018.

WHEREAS, neither the application for renewal of Plenary Retail Consumption License #1344-33-003-013 nor the required State or local fees were submitted by CG Jersey, Inc. t/a Fratello's (hereafter "Licensee") within the time permitted under *N.J.S.A.* 33:1-12.13 (i.e., not later than July 31, 2018); and,

WHEREAS, the aforementioned Licensee sought relief from the Acting Director of the Alcohol Beverage Control Commission to file for a "new" license pursuant to *N.J.S.A.* 33:1-12.18 for failure to timely renew for the 2018-2019 license term on January 16, 2019 and the Special Ruling dated January 16, 2019 was issued after payment of the required State fees; and,

WHEREAS, the Licensee remitted the required Municipal fee on January 10, 2019, submitted the required 12-page application on January 15, 2019 and advertised on January 18 and 25, respectively, in *The Asbury Park Press* as required pursuant to *N.J.A.C.* 13:2-2.5:1; and,

WHEREAS, Tax Clearance Certificate for the 2018-2019 license term was issued by the State of New Jersey.

NOW, THEREFORE BE IT RESOLVED that the Plenary Retail Consumption License #1344-33-003-013, issued to CG Jersey, Inc. t/a Fratello's for the premises located at 810 The Plaza, Sea Girt, New Jersey be and the same is hereby approved for renewal for the period July 1, 2018 to June 30, 2019, inclusive.

B. Resolution No. 32-2019: Accept Proposal of The Goldstein Partnership for preliminary design services (non-fair and open award); cost including expenses: \$8,950

WHEREAS, the Borough of Sea Girt requested a proposal The Goldstein Partnership, Maplewood, NJ for the preparation of preliminary design studies in conjunction with a project to create new administrative offices and expanded library facilities and received the same on January 24, 2019; and,

WHEREAS, these studies must take into consideration the expressed needs of the Borough and the newly discovered historic design attached to the existing Library structure and as specified in the Proposal (attached hereto); and,

WHEREAS, funds are provided for these services in Ordinance No. 03-2019 and the Chief Financial Officer has so certified.

**NOW, THEREFORE BE IT RESOLVED** that the Proposal of The Goldstein Partnership, Maplewood, NJ for the preparation of preliminary design studies at the lump sum amount of \$8,950 be and the same is hereby approved.
