13. ADMINISTRATOR REPORTS

- A. **NJ Transit Beacon Boulevard Crossing Rehab Update:** Due to mandatory temporary furloughs of key Department of Transportation staff, the crossing rehabilitation for Beacon Boulevard has been postponed from its original start date of August 13th to the tentative new date of August 27th. The schedule will run the same, work will begin that Thursday and run through the weekend to the following Thursday, the 3rd of September.
- B. **Coronavirus Update**: Outdoor dining has been in effect since late June and there has been 1 complaint to date; however, the complaint does not substantiate a violation of the Outdoor Dining Protocol adopted by Council, but general dissatisfaction with the approval granted.

C. Beach:

- a. The Beach is open full-time through Labor Day;
- b. In furtherance of the social distancing requirements of the Governor's Executive Orders, the sale of daily badges is limited to 750 per day.
- c. For their protection and the protection of our staff, beach patrons are urged to wear masks when interacting with our staff and with other patrons; when using our facilities and when on the boardwalk;
- D. Census 2020: It's very important to our community and our families in our community.
 - a. Accurate Census data determines how many representatives we have our voice and power in government.
 - b. Census data helps determine where more than \$45 billion in federal funding is distributed each year for New Jersey. The more accurate the information the moredollars we all get. Crescent Parkway Tree Update: The Borough has obtained a second opinion on the condition of the remaining trees from another Certified Tree Expert, who has identified all but the eastern-most tree as at higher risk for limb and stem failure. The Shade Tree Commission members are recommending that the Borough follow the advice of the two experts and remove the three of four remaining trees that have been deemed dangerous or at higher risk for failure to reduce the Borough's liability before someone is injured or property damaged. Please note that it is the Borough's intention to replace the trees this fall when conditions are suitable for planting.
